

Alumni 10% and 25% Fee Discount Scholarship

Terms and Conditions

Eligibility

- 1. You are eligible for an alumni fee discount for Murdoch University ("Murdoch") tuition fees if you meet all the following criteria:
 - (a) you have successfully completed an undergraduate degree of Bachelor level or a Master (coursework) level degree from one of Murdoch University's Australian campuses; and
 - (b) you have applied for a place in an eligible course (as defined in clause 3 below) at one of Murdoch's Western Australian campuses.
 - (c) You commence your course before the end of 2025.
- 2. You are not eligible to receive the alumni fee discount if you have been awarded a different Murdoch-funded scholarship to undertake an eligible course and that scholarship is greater than the applicable alumni fee discount.
- 3. An Eligible Applicant will only be considered for an alumni fee discount for one of the following Murdoch study options:
 - (a) a Graduate Certificate; or
 - (b) a Graduate Diploma; or
 - (c) Master by course work.

Fee Discounts

An eligible applicant will be considered for one of the alumni fee discount options set out below:

Discount Option 25% discount of tuition fee

Offered to eligible applicants who commence an eligible course in the next possible teaching period within 12 months of completing a Bachelor or Master level course at one of Murdoch's Australian campuses. e.g., completing an undergraduate degree in November 2024 and commence a Graduate Certificate course in February 2025. If however, the Postgraduate program is *not* available in the next immediate teaching period, and a break in study is unavoidable, then the 25% Scholarship will roll over to the next available teaching period, as long as the break does not exceed 12 months from completion of the previous qualification.

Discount Option 10% discount of tuition fee

Available to eligible applicants who commence an eligible course more than 12 months after completing a Bachelor or Master level course at one of Murdoch's Australian campuses. (e.g., Complete an undergraduate degree in November 2023 and commence a Master level degree in July 2025)

Restrictions

- 1. Only one alumni fee discount allowed for an applicant at any one time.
- 2. The alumni fee discount is available to domestic and international Students
- 3. The alumni fee discount will not apply to fees incurred for:
 - (a) Murdoch's short courses
 - (b) Murdoch's Bachelor of Science/Doctor of Veterinary Medicine or Master of Psychology courses

- (c) Murdoch's Master of Teaching, Grad Dip in Asian Language, Postgraduate Nursing, Postgraduate Biosecurity, Postgraduate Food Science/Security, Postgraduate Plant Biosecurity or any other Commonwealth Supported Courses
- (d) Murdoch's undergraduate degrees (including undertaking a second Bachelor level program).
- (e) Murdoch's units delivered through FutureLearn or Open Universities Australia or any other online course delivery provider used by Murdoch
- (f) cross institutional units completed with another university, or
- (g) units undertaken at a Murdoch campus outside of Western Australia.
- 4. The alumni fee discount only covers tuition fees and does not cover any other student expense, fees or charges such as the Student Services Amenities Fee (SSAF), fines, administrative fees or ancillary fees or costs.
- 5. The alumni fee discount can be revoked at Murdoch's discretion:
 - (a) if the recipient is awarded a Murdoch-funded scholarship and that scholarship is greater than the applicable alumni fee discount:
 - (b) if the recipient is eligible for a 25% discount and defers the start of her or his studies.
- 6. The alumni fee discount cannot be transferred to a Murdoch campus or partner outside Western Australian, or to another university.

Availability

- 1. The alumni fee discount will be available for students applying to commence an eligible course in 2024 & 2025.
- 2. Eligible Applicants will be considered for an alumni fee discount at the time of applying for entry to the eligible course. If the scholarship is not mentioned on your offer letter and you believe you are eligible, please contact our team at scholarships@murdoch.edu.au
- 3. Subject to restriction 1, there is no limit on the number of consecutive eligible courses undertaken for which an alumni fee discount can apply.
- 4. A change in enrolment by a recipient will require the recipient's eligibility for an alumni fee discount to be re-assessed. This may result in a reduction from 25% to 10% if the new course commences more than 12 months since completion of a Murdoch course.
- 5. The alumni fee discount will always be applied as discount to tuition fees.
- 6. Murdoch's alumni from offshore trans-national education locations are not covered by these terms and conditions however separate alumni discount fee arrangements may apply. Please contact our team via email scholarships@murdoch.edu.au
